12) Discussion/Action Item – Status of Laguna Grande Regional Park (*R. Payan*)

General Manager Rafael Payan gave an update on the status of improvements to Laguna Grande Regional Park and answered Board Member questions.

- Scott Waltz, representing the Fort Ord Rec Trail and Greenway (FORTAG) project asked if the way in which the ongoing search for a consultant and procedures for evaluating habitat and trails blends with what's happening with TAMC in terms of seeking grants for the section of Laguna Grande that's identified in FORTAG, and the coordination that might happen. General Manager Payan announced that staff will make the FORTAG planning an integral part of Laguna Grande planning.
- Kathie Buaya shared her excitement that the Laguna Grande improvements project has been resurrected, and hope that new Palo Corona signage could be used at Laguna Grande, and also shared that another resident expressed an interest in having a 9-hole disc golf at Laguna Grande.
