### MINUTES

- 1) **6:30 p.m. Call to Order** – The meeting was called to order at 6:30.
- 2) **Roll Call** – Roll call was taken.  
PRESENT: Directors Anderson, Potter, and Raskoff (Sorenson arrived at 6:31; Lee arrived at 6:32)  
ABSENT: None
- 3) **Approval of Agenda** – Upon motion by Director Raskoff, seconded by Director Anderson, the agenda was unanimously approved by roll call vote. (Vote: 4-0, Ayes: Anderson, Potter, Raskoff, and Sorenson; Absent: Lee)
- 4) **Public Comments** – Esther Malkin, president of the Laguna Grande Neighborhood Association asked that at the end of the Laguna Grande JPA meetings, the date of the next meeting be announced.
- 5) **Presentation** – San Jose Creek Trail Public Access Update (*J. Smith*) (*Presentations are informational only, and no formal Board action will be taken. Public speakers are limited to three minutes.*)
  - Planning and Conservation Manager Jake Smith gave an update on the soon-to-be opened San Jose Creek Trail.
  - Project partners, Rachel Saunders of the Big Sur Land Trust, John Hiles of CA State Parks, and Kathleen Lee of Point Lobos Foundation expressed their support for and excitement about the trail opening.
  - Volunteer Naturalist and hike leader Mary Dainton announced that a hike on the new trail is scheduled for November 3<sup>rd</sup> and expressed a desire to allow parking near the State Parks entrance.
  - Rachel Saunders announced that when the Big Sur Land Trust received a grant for the trail, they learned that an expensive turn lane would have been required to allow for parking access.
